4.2 FAMILY IN LAW


4.2.1 Relative

Civil Code Article 725 The following persons shall be relatives, (i) a relative by blood within the sixth degree,

- (ii) A spouse; and,
- (iii) a relative by affinity within the third degree.

4.2.2 Parental authority

(Right and Duty of Care and Education)

Civil Code Article 820 A person who exercises parental authority holds the right, and bears the duty, to care for and educate the child for the child's interests.

Civil Code Article 822 A person who exercises parental authority may discipline the child to the extent necessary for the care and education under the provisions of Article 820.

4.4 INTERNATIONAL MARRIAGE AND DIVORCE

Act on General Rules for Application of Laws, Act No. 78 of June 21, 2006 (Formation and Formalities of Marriage) Art. 24 (1) The formation of a marriage shall be governed by the national law of each party.

(2) The formalities for a marriage shall be governed by the law of the place where the marriage is celebrated (lex loci celebrationis).
